#### **New Business:**

## Item 1: President's Update

- Repairs -

Emergency repair on a leak happening now. The water manager is busy with the repair and unable to attend today's meeting

Flood drains. Cleaned from Kenneth to end of ingersoll.

- Consumer Confidence Report need to sign form and post on website (Completed 6/16/23)
- Calendar Year for Invoicing. Invoice exceptionally from April to December. Next year from Jan to Dec. VP Motions to change the invoicing to calendar year: President seconds. M/D/V

## Item 2: Firewise Community - AVP /Sec

Time to report and renew status: add community hours and expenses of recent weed eating and clearing and individual household expenditure on home hardening efforts. Several households obtained grant money for implementing the Firewise mitigation officer's suggestions. Involve the ACC in collecting data. Apply for a chipping grant [ACTION NEEDED-AVP]

- Several undeveloped lots need clearing. ACC to send notices. Take photos and communicate with lot owners. [ACTION NEEDED – AVP, ACC]
- Letter for Wilkinson same as last year for 2023 Calfire Grant

#### Item 3: Grants Status - VP, P

- New Grant: Calfire Foundation. June 30th deadline. State grant up to 25K to help non profit organizations in disaster prevention. Apply to clear the entrance and the back of the property. Map and measurements needed from Secretary. (Completed 6/16/23)
- We can use the bid received a few years ago. PG&E has fell many trees. It is a fire hazard..
- Update on the State grant for engineering AND construction involving the Water Board, RCAC and Coleman engineering: on final stages of approval. 1.5 million or less is the total grant funding for new tanks, water pipes, and meters. The Board has requested to include the construction of a new well and lawyer fees to ensure the easement is legally

documented and recorded. The budget is limited by the State. The state will shoulder the CEQA expense. VP attended the California state advisory Water board. They have a 7 million budget. Lake Francis Estate has received one million.

- American Corps of Engineers: Septic to Sewer project. Very long term project. The environmental impact of narrow lots with individual septic systems is unknown. Columbia university engineers visited to draft a preliminary design. Septic to Sewer will require 100% members vote. Not for a near future. A survey prepared by the engineers will be sent out shortly to all members.
- Yuba Water Agency offers small grants: ex: generator grant. They have offered to co-fund grants we obtain from other sources.
- Bear Yuba Trust. Meeting with Yuba Water agency to see about the possibility of Yuba water agency or LFMWC purchasing the 85 acres with grant funding in order to prevent development and to create a fuel break around the Estate. Land Conservation and nature habitat grants are available. The land would be managed by environmental agencies.

Brush clearing rates are more reasonable as well.
